## **A LIFELINE FOR KIDS IN NEED**

Kids and teens in the care of Bucks County Children & Youth Agency (C&Y) got a rough start in life, having suffered neglect, abuse or trauma.

Bucks for Kids partners with C&Y caseworkers to fund the individual "extras" these kids need, such as:



Education/Tutoring

Most children are able to stay in their homes while their parents receive services coordinated by their caseworker. Each child's safety and well-being are carefully monitored until the case is closed.


Sometimes the child needs to be placed in a foster home or with a relative temporarily. During placement, all family members receive support and participate in programs to resolve parenting and life-style issues. The main goal is family reunification. However, if that is not possible, permanent placement with a relative or adoption will occur.

While Bucks County pays for housing, food and medical care, foster parents only receive about \$16 per day. They can't afford "extras" that normalize life for these kids - some of whose parents are absent, disabled or incarcerated.

When C&Y receives a call about abuse or neglect, caseworkers respond immediately with a visit to the home and interview and begin to service the family, if the report is founded.
